This Privacy Policy explains how LLC KIM AFFILIATES collects, uses, stores, and protects your personal data when you use our website kim-affiliates.com and partner platform tools.kim-affiliates.com.

We are committed to respecting your privacy and protecting your personal data in accordance with the applicable laws of Ukraine and the General Data Protection Regulation (GDPR).

1. Information We Collect

We may collect the following categories of data:

- **Registration data:** name, email, username, account ID, Telegram or other contact information.
- **Payment data:** bank account details, crypto wallet addresses, or other payout information.
- **Technical data:** IP address, browser type, device information, operating system, language, cookies, date and time of access.
- **Traffic and activity data:** information about clicks, leads, conversions, traffic sources, postbacks, and API requests.
- **Communication data:** messages exchanged with account managers or support team.

2. How We Use Your Data

We process your personal data for the following purposes:

- To provide access to our partner platform and its features.
- To communicate with you regarding your account or campaigns.
- To generate reports and optimize campaign performance.
- To process affiliate payouts and financial reporting.
- To prevent fraud, misuse, or violations of our rules.

- To comply with legal obligations.

3. Cookies and Tracking

We use cookies to:

- Authenticate users;
- Store referral and click IDs;
- Analyze user behavior and traffic sources;
- Improve platform functionality and user experience.

You can manage or disable cookies in your browser settings.

4. Data Sharing with Third Parties

We do **not** sell or disclose your personal data to third parties, except in the following cases:

- Sharing with payment providers to process payouts;
- Collaboration with infrastructure or technical service providers (e.g., hosting, email systems) under confidentiality agreements;
- Legal requests from authorized public authorities or as required by law.

5. Data Security

We implement appropriate technical and organizational measures to safeguard your data, including:

- Encrypted SSL connections;
- Access control and internal data restriction;
- Regular security updates and system monitoring.

6. Your Rights

You have the right to:

- Access your personal data;

- Request correction or deletion of your data;
- Restrict or object to data processing;
- Receive your data in a structured, machine-readable format;
- Withdraw consent at any time (if data processing is based on consent);
- Lodge a complaint with a data protection authority.

7. Data Retention


We retain your data for as long as necessary to fulfill the purposes described in this policy or until you delete your account or request erasure, unless a longer retention period is required by law.
